What will be the actual size of the volume after it is created?

2.An administrator is using the Data Protection wizard in PowerVault Manager to create a new remote replication set between a primary and a secondary PowerVault ME5 system.

To establish the peer connection to the secondary system, which two of the following pieces of information must be provided in the wizard? (Choose 2.)

- A. The serial number of the secondary system's enclosure.
- B. The IP address of a management port on the primary system.
- C. The username and password for a user with a 'manage' role on the secondary system.
- D. The IP address of an available iSCSI or FC host port on the secondary system.

3.An administrator is monitoring system performance in PowerVault Manager. In the Performance panel's expanded view, they select "Live" from the timeframe dropdown. After returning to the dashboard's compact view, they notice the performance graphs are not updating in real-time.

What is the reason for this behavior?

- A. The "Live" view is only available to users with the 'manage' role.
- B. The compact view does not display live metrics; it shows the most recent historical data instead.
- C. A web browser refresh is required to enable live updates in the compact view.
- D. The storage system must be rebooted for the live compact view to become active.

4.An administrator is reviewing the "Alerts to Acknowledge" list in the Alerts panel. They select an alert that has a "Resolved" status and click the "Acknowledge" button.

What is the result of this action?

- A. The alert is permanently deleted from the system and cannot be viewed again.
- B. The alert remains in the "Alerts to Acknowledge" list but is now marked as acknowledged.
- C. The alert is removed from the "Alerts to Acknowledge" list and will only be visible in the "History" table.

5.An administrator needs to download the complete system diagnostic logs from a PowerVault ME5 controller using a command-line SFTP client.

- C. Log in as a user with FTP/SFTP interface permissions.

D. Use the `get logs <filename>.zip` command.

E. Connect to the SFTP service on the controller's management port IP address.
